- The posts carry other allowances / benefits as admissible under the rules of the Corporation.
- **AGE LIMIT:** Minimum 18 years and maximum 32 years as on **31/12/2008** (Relaxable 3 years for OBC candidates for the post reserved for them). Age relaxation for Ex-Serviceman/PH candidates as per Govt. directives.
- SC/ST/PH candidates appearing for written test / interview shall be reimbursed second class rail/bus fare by the shortest route as per rules on production of tickets.
- Applicants from Govt./Semi Govt./PSU must apply through proper channel.
- The period of experience will be determined as on **31/12/2008**.
- Applications without supporting documents/incomplete/not fulfilling the prescribed criteria in any respect are liable to be rejected.
- **Selection Methodology:** Selection would be based on written test / trade test and personal interview of short listed candidates. The candidates will have to pass through each stage including medical fitness successfully for being adjudged suitable for selection.
