Qualification & Experience:

The candidate should have completed BE/ B.Tech in Engineering from a recognized University/ Institute. He should have relevant professional experience of at least 10 years in E&P Company (ies)/Oil & Gas Services Company (ies) in India or abroad including at least 5 years as Drilling Engineer with demonstrated proficiency.

The candidate should have sufficient experience in planning, coordination, field implementation, trouble shooting and general support of well construction operations. He should also have experience in casing, tubing, mud, cement and bit design with emphasis on cost effectiveness, experience in well completion design and implementation. The candidates should have IADC (International Association of Drilling Contractors) certified certificates on blow-out prevention and associated drilling activities and HSE compliance/certificate.

The candidate should preferably be familiar with Drilling Information Management System(DIMS).

Job Description:

Outline

To provide technical support for exploration activities viz. drilling of exploration wells in two Type-S blocks in Cambay basin, where IOC is the operator, and also in other E&P blocks, where IOC is not an operator. The incumbent should have sound knowledge of drilling wells. He has to plan, design and supervise drilling of wells in Type-S blocks. He is to provide support for counter checking drilling operations at other E&P blocks, where IOC is not an operator. He should also provide technical back-up for evaluation of new E&P opportunities for acquisition by IOC. The indicative job functions are as under:

Job Functions

- Planning of drilling operations and scheduling
- Perform and facilitate rig scheduling, drilling permit applications, selection of drilling locations and associated planning
- Design wells, specify equipment and procedures
- Prepare detailed well estimates
- Solicit and evaluate bids for drilling services and equipment
- To plan and design technical specifications for various tender documents and technical evaluation for drilling of wells along with associated works/material/services requirements
- Ensuring contractor personnel, services and material, are available at rig site when required so to avoid any delay in operations
- Supervising drilling and completion operations carried out by Company's and Contractor's personnel at rig site
- Coordinating drilling and completion activities in accordance with programme, Company procedures and best practices

- Monitoring the consumptions and stock of materials available at rig site, and to make request for personnel, materials, and services in due time in order to avoid any delay in the operations
- Representing Company at rig site in all matters
- Ensuring that drilling and completion operations are carried out in safety, with good oil field practice and in accordance with programme and all the relevant company standards and HSEQ procedures
- Interface with other drilling/completion specialists, G&G team, reservoir development team, operations personnel, and HES as required
- Perform drilling supervision and support as required
- Evaluate and implement new technology as appropriate to improve drilling performance
- Compile, analyze, and report drilling performance metrics
- Develop and implement new drilling and completion well designs strategies
- Mentoring of drilling engineers and well-site specialists/Mud engineers etc.
- Technical liaison with service providers
- Personnel, equipment and material safety at rig site operations
- Any other requirement connected with E&P work
