M.Sc in Chemistry or Polymer Science with minimum 60 percent marks from a recognized University/Institute.

- Polymer OR
- Material Sciences

#### Experience:

Applicants should have minimum one year experience. The experience should be preferably on **any one** of the following:

- Testing and Characterization of Polymers using UTM, Impact tester, MFI tester, Density gradient column, particle size analyzer, DSC, TGA, DMA, Capillary/Rotational Rheometer, viscometer etc.
