Hence the applicant does not meet the eligibility criteria of providing godown land</p> <p>2. In item no 12.1 of application form, the applicant has declared that he has fund of Rs 15 lacs, but has not attached any supportive document to verify the same. Moreover, as per selection guideline, score of fund for 15 lacs comes out to be only 21.43 which is not meeting the eligibility criteria of scoring minimum 27 marks.</p>

The candidate has attached one secondary school certificate in the name of Farooqui Farzeen Zafeer, in which DOB mentioned is as 18-11-2000. Moreover, In application, Name of the applicant is mentioned as Farooqui Mohammad Ahras which also is not matching with the attached secondary school certificate which is in the name of Farooqui Farzeen Zafeer.</li> <li>2. Applicant has left the item no 12 of application form blank, which is regarding the capability to provide finance. Also, No supportive documents have been attached. Hence applicant does not meet eligibility criteria of providing land for godown.</li> <li>3. Applicant has opted for "firm offer" for providing land for godown in item no 11A2 in application form and ticked "yes", but other details of item no 11A2 regarding offered godown land details is totally left blank. Also, No supportive documents have been attached. Hence applicant does not meet eligibility criteria of providing land for godown.</li> </ol>
