

## Indians bagged 73% of H-1B visas in 2022

Mumbai India has been again approved the H-1B visas in 2022, getting 5.4 lakh visas, of which 4.1 lakh were issued to Indians.

This means, nearly three-quarters of every H-1B visa granted will go to India-born persons. The second most countries of H-1B visas are China, with a comparatively lesser number of 30,000 (5.5% of total), Canada 23,000 (4.3%) and Mexico 18,000 (3.3%).
