- Candidates must submit a copy of Experience Certificates (s), Apprenticeship Completion Certificate issued by previous employer(s) or copy of Appointment Letter and Last Pay slip, (Copy of Work Order and Proof of working in Large Industrial Establishment ,as applicable are also required to be produced) as a proof of required post qualification experience.
- Candidates belonging to the SC/ ST/ OBC / PwBD shall be required to produce their caste / disability certificate issued by the Competent Authority specified by the Govt. of India (Ministry of Social Justice & Empowerment).
