Qualification : Ph.D in Polymer Chemistry from a recognized University / Institute.

OR Post Graduate in Chemical Engineering from a recognized University / Institute with specialization in Polyolefins. The candidates must have obtained minimum 60% marks in Graduation as well as in Post- Graduation.

The candidates must have knowledge of :

- Different technologies available for PE / PP
- Short-term and long-term perspectives for business environment and facilitating development of newer applications, polyolefin grades and specialty grades.
- <u>Experience</u> 20 years of R&D experience after the basic degree in the area of polyethylene / polypropylene.
  - Working in polyolefin R&D lab(s) with expertise in trouble-shooting. Optimization, evaluation / development of catalysts, development of new polymer grades, post-reactor modifications and additive optimization etc.
  - Setting-up and design of micro-reactors, pilot plants and other related laboratory facilities for polyolefin research.
  - Characterization and evaluation of Ziegler Natta / Metallocene catalysts.
  - New generation catalyst for polyolefin processes.
  - Additional knowledge of structure property performance relationships, optimization of additive, polymer testing and processing equipments

# 2. DEPUTY MANAGER RESEARCH (Grade C) / SENIOR RESEARCH OFFICER (Grade B) / RESEARCH OFFICER (Grade A)

<u>Qualification</u> : Ph.D in Chemistry with specialization in organo-metallics

OR

Ph.D in Polymer Science with specialization in organo-metallics catalysts and polymerization processes with knowledge of characterization techniques used for polymer analysis / testing

OR

M.Tech. Polymer Engineering / Technology with specialization in Polymers

The candidates must have obtained minimum 60 % marks in the Graduation as well as in Post Graduation.

<u>Experience</u>: **Grade** A – No experience necessary after the basic degree as per the minimum qualification required. However, candidates having some R&D experience will be preferred.

**Grade B / C**– The candidate must have minimum 6 years of R&D experience for Grade – C and minimum 3 years of R&D experience for Grade – B, after the basic degree in both the cases, in the area of polyolefins (polyethylene/polypropylene), particularly in some of the following aspects :

- Synthesis of organometallic compounds
- Handling of sensitive chemicals / materials
- Synthesis and characterization of Ziegler-Natta/metallocene catalysts
- Polymerization/copolymerisation of ethylene, propylene and higher olefins using Ziegler-Natta/metallocene catalysts
- Mechanical Testing and characterization of polyolefins
- Polyolefin rheological aspects
- Polymer processing techniques
- Polyolefin composites / blends

<u>Selection Methodology</u> : The candidates meeting the prescribed eligibility criteria / experience requirement shall be subjected to Personal Interview.

**Grade and Scale of Pay**: Besides Basic Pay and Industrial Pattern of DA, other allowances include HRA, Medical Facilities, Performance Linked Incentive, Productivity Linked Incentive, Gratuity, Contributory Provident Fund, Employees' Pension Scheme, Group Savings Linked Double Accident Insurance, Leave Encashment, Leave Travel Concession, LFA, Contributory Superannuation Benefit

### **Concessions / Relaxations :**
