The Haldia-Mourigram-Rajbandh-Barauni Pipeline(HMRBPL) transports petroleum products from Haldia to Mourigram-Rajbandh-Barauni with annual capacity of 2.5 MMTPA.

Out of the two posts of Line Inspection Attendant-I at Sl No.-02, one is reserved for Ex-Serviceman.

The post at Sl No.-01 is also suitable for physically handicapped persons in OH category i.e. Hunchback/Deformity of chest. The post at Sl No.-02 is also suitable for Physically Handicapped persons in OH category i.e. one arm partially affected/Deformity of chest and in HH category i.e. partially deaf. However, such PH candidates will be considered for selection by general standards of merit.

In addition to the Basic Pay, DA (present rate of DA being 96.8% of Basic Pay) and HRA, other benefits like Provident Fund, Gratuity, LTC, liberalized medical benefits, productivity / performance linked incentive, leave encashment, superannuation benefits, Post Retirement Medical Attendance benefits etc. shall also be admissible according to the rules of the Corporation.

**Age limit** : Between 18-32 years of age as on 01.04.2009.

**Application Fee :**

Application fee (non-refundable) of Rs. 100/- (Rs. One Hundred only) through crossed Demand Draft in favour of INDIAN OIL CORPORATION LTD. – PIPELINES DIVISION payable at State Bank of India, Elgin Road Branch, Kolkata(Bank Code:1768) should be enclosed along with application form. Any other mode of payment is not acceptable and application not accompanying the application fee will be rejected without any further reference to the applicant.

**Concessions/ Relaxation :**

1. Upper age relaxation of 03 years for OBC candidates for the post reserved for them and 10 years for Physically Handicapped candidates. Age relaxation for Ex-Servicemen as per rules.
2. SC/ST and PH candidates are exempted from payment of application fee.

**Selection Methodology:**

The selection methodology will comprise of Written test, Physical Fitness test and Personal Interview of short listed candidates. The candidates will have to pass through each stage including medical fitness successfully for being adjudged as suitable for selection.

**General Instructions:**

1. Service is transferable to anywhere in India.
2. Candidates serving in Government/ Semi Government Departments / Public Sector Organizations /Local Bodies must send their application through proper channel or produce “No objection Certificate” at the time of appearing in the Test/ Interview. In case, the candidate fails to submit/produce the certificate his/her candidature will not be considered.

3. Candidates should apply in the prescribed format affixing recent passport size coloured photograph on the application form duly signed along with application fees, attested copy of mark sheets, educational qualification certificates, caste certificate, recent OBC certificate, disability certificate (for PH), Ex-servicemen Discharge Certificate (for EXSM).
4. Incomplete applications or applications received after the due date will be rejected.
5. For claiming the benefit of Physically Handicapped, the candidates should attach Medical Certificate issued by a Medical Board attached to the special Employment Exchange/ Vocational Rehabilitation Center for PH or Head of concerned Department of a Government Civil Hospital satisfying the prescribed disability criteria (minimum 40% of relevant disability).
7. The decision of the management in all matters relating to eligibility, acceptance or rejection of the application, mode of selection will be final and Management will not entertain any enquiry or correspondence in this regard.
8. Application of a candidate having higher qualification than the prescribed qualification shall be rejected.
9. Canvassing in any form shall disqualify the candidature.
10. Management reserves the right to fix/increase the minimum percentage of cut-off marks in the prescribed qualification for calling the candidates for test/interview.
