The 935 Km long Haldia Barauni Crude Oil Pipeline transports crude oil from Haldia to Barauni Refinery with annual capacity of 7.5 MMTPA. IOCL has recently commissioned 328 km long, 11 MMTPA capacity Paradip-Haldia Crude Pipelines with Single Buoy Mooring Terminal & Tank farm at Paradip. The integrated entity is renamed as **Paradip-Haldia-Barauni Pipelines**.

## **Application Fee:**

#### Concessions / Relaxation:

- 1. Upper age relaxation of 10 years for Physically Handicapped candidates. . Age relaxation for ex-servicemen as per rules.
- 2. SC/ST /PH candidates are exempted from payment of application fee.

#### **Selection Methodology:**

The selection methodology will comprise of **Written test, Trade test and Personal Interview** of short listed candidates. The candidates will have to pass through each stage of selection process for being adjudged as suitable for selection.

# **General Instructions:**

- 1. Service is transferable to anywhere in India.
- 2. Candidates serving in Government/ Semi Government Departments / Public Sector Organizations /Local Bodies must send their application through proper channel or produce "No objection Certificate" at the time of appearing in the Test/ Interview. In case, the candidate fails to submit/ produce the certificate his/her candidature will not be considered.
- 3. Candidates should apply in the prescribed format affixing recent passport size colored photographs on the application form duly signed along with application fee, attested copies of mark sheets, educational qualification certificates, caste certificate, disability certificate (for PH), Ex-servicemen discharge certificate (for EXSM).
- 4. Incomplete applications or applications received after the due date will be rejected.
- 5. Candidates from ST/OBC/PH/Ex-Servicemen category should submit their caste/PH/ Ex-Servicemen certificate issued by Competent authority along with the application form, in support of their claim of belonging to ST/OBC/PH/Ex-Servicemen category.
- 6. For claiming the benefit of Physically Handicapped, the candidates should attach Medical Certificate issued by a Medical Board attached to the Special Employment Exchange/Vocational Rehabilitation Center for PH or Head of concerned Department of a Government Civil Hospital satisfying the prescribed disability criteria (minimum 40% of relevant disability)
- 7. The decision of the management in all matters relating to eligibility, acceptance or rejection of the application, mode of selection will be final and Management will not entertain any enquiry or correspondence in this regard.

- 8. Application of a candidate having higher qualification than the prescribed qualification shall be rejected.
