Minimum Qualification and Experience:

- Diploma in Chemical / Petrochemical Engineering or B. Sc. with Chemistry as Principal Subject and Physics & Maths as Subsidiary Subjects with first class (Pass class in case of SC/ST candidates). The prescribed qualification should be as a regular student of full time course.

The candidates will have to qualify each stage of selection process successfully for being adjudged suitable for final selection.

- 6. Applicants from Govt. /Semi Govt. /PSU must apply through proper channel or produce "No objection certificate" at the time of appearing in the test/interview.
- 7. Ex-servicemen fulfilling Eligibility Criteria can apply against the above post along with relevant service certificates and qualification documents prescribed above.
- 8. General & OBC candidates are required to send a crossed D/D of Rs.100/- (nonrefundable) as application fee in favour of 'ACCOUNTS OFFICER, GUJARAT REFINERY', payable at Baroda. No other mode of payment shall be accepted (SC/ST/Ex-Serviceman candidates are exempted from payment of Application Fee).
