

India Kanthapuram A P Aboobacker Musliyar said the Quran teaches that women should remain within their homes and that bringing them into public spaces could cause "great destruction".

He was defending a recent circular issued by his faction of Samastha, which sought to restrict women's presence on public platforms. Kanthapuram also justified purdah as a means of protecting women's dignity.

The remarks triggered widespread criticism. But the Indian Union Muslim League (IUMML), a key constituent of the Congress-led UDF govt, described them as a "scholarly expression" and suggested that they may have been motivated by concerns over women's safety.

The controversy has exposed a widening tension within the state's Muslim community. On one side are young women claiming greater visibility through education, politics, work and social media. On the other are clerical and political forces seeking to regulate the terms of that visibility.

The Onam Flashpoint

The Samastha directive came amid a growing wave of young Muslim women participating

in shared activities of their performance on social media. Their participation drew widespread praise, particularly because it reflected the state's long-standing tradition of celebrating Onam as an inclusive and secular festival. Several Muslim colleges, especially in Malabar, also allowed such programmes.

For many young women, the celebrations were not simply about taking part in a cultural event. They were an assertion that they could decide how they dressed, where they went and how they participated in public life.

The response from conservative sections of the community was swift. Earlier, protests had also been voiced against co-ed school and college students taking part in Onam celebrations and against mixed-gender physical work-out programmes.

A Political Sign Of Change

The 2026 assembly election had appeared to offer a powerful counterpoint to such conservative pushback.

The 75-year-old IUMML, which has often positioned itself as a political counterweight to orthodox forces

within the community, got its first woman MLA when Fathima Thahililya — a young leader who had openly pushed for greater gender parity within the party despite criticism from clerics — defeated LDF convenor T P Ramakrishnan in Perambra, Kozhikode.

IUMML had fielded women candidates twice before, but neither had won. Fathima's victory appeared to signal the emergence of a more progressive political space within Kerala's Muslim community — one in which women could claim equal political opportunity.

The conflict is unfolding against the backdrop of considerable progress made by Muslim women in education.

According to the 'State of Muslim Education in India', the gross enrolment ratio of Muslim students in higher education in Kerala was 20%. Muslim women performed better than men, with a GER (gross enrolment ratio) of 25% compared with 16% for men.

An analysis of data from the All India Survey on Higher Education for 2023-24 shows a similar pattern at the postgraduate and re-



search levels. In major disciplines across PhD, MPhil and postgraduate programmes, 1,54,878 Muslim women were enrolled, compared with 1,08,526 men.

This educational progress, however, has not translated into equal freedom in public or professional life.

A study of Muslim women in Malappuram found that higher education was strongly associated with employment, economic independence and greater participation in household financial decisions. At the same time, conservative attitudes, religious factors and family responsibilities continued to constrain women's employment.

"Women from the Muslim community have made so much progress in Kerala only by ignoring such decrees of Muslim clergy," said Dr Liyaqath Ali, principal of Government Col-

legiums about dignity and safety. Women have historically been used to limit women's mobility, education, employment and participation in public spaces.

"Women's struggle for public space is a constant power struggle when they rise in power and authority," said V P Zuhra, president of NISA, a progressive Muslim women's forum. "Some men can't accept that every woman is an individual, with immense capacity and capability to decide for herself. It is high time that religious and vote-bank politics stopped treating women as a commodity. Such behaviour leaves a black spot on Islam as a religion and is truly unacceptable."

Safiya PM, an activist who has filed a writ petition in the Supreme Court challenging the mandatory application of Muslim Personal Law to individuals who have officially renounced Islam, said the current pushback had deeper political roots.

"After the Babri Masjid demolition, a narrative took hold even among Kerala Muslims — who were otherwise known for being progressive, educated and secular — that they needed to unite to counter the perceived threat by turning more strictly to religious teachings and norms," she said.

"This led to a return to religious texts, which in turn was used to curtail the freedom of Muslim women using 'the book' and affected their progress and visibility. In recent years, however, Muslim women have been steadily reclaiming public space through education, entrepre-

always like to place women as inferior to them," he said. "This needs to end for any society to evolve and progress."

The Political Reaction

The political response to the controversy has been divided.

Chief minister V D Sathesnan, whose govt depends on IUMML support, rejected Kanthapuram's interpretation as a "misreading of Islam". He said it was unacceptable that "ideas from the 19th century were still being expressed in the 21st century".

Women and child development minister Bindhu Krishna also criticised Kanthapuram's position, while stressing that everyone had the right to freedom of expression and religious belief.

Several leaders of prominent secular political parties, however, either remained silent or defended Kanthapuram's right to express his religious views. CPM leader K T Jaleel and some Muslim organisations aligned with the party supported the cleric's position. Senior CPM leader P Jayarajan, while defending the right to express religious views, said "prescriptions restricting women's public life were open to democratic criticism".

The competing responses point to the political sensitivity of the issue. Religious leaders retain influence over sections of the community, while political parties depend on Muslim voters. Challenging conservative positions too directly can, therefore, carry an electoral cost.
