Sealed offers are invited in two bid system i.e, (A) Technical Bid (B) Financial Bid from interested parties holding valid and clear marketable title of land in possession, before the date of release of this advertisement for transfer of plot of the land by way of outright Sale / Lease (minimum 19 years 11 months with renewal option) to Indian Oil Corporation Limited for setting up a Retail Outlet at 52 locations in Tamil Nadu and Pondicherry as mentioned below:

The followings may kindly be noted:

- 1. This advertisement is for procuring the suitable land only by way of outright Sale / Lease and not for appointment of Retail Outlet Dealership or giving/causing any right to anyone offering its/his/her land to claim any interest of any nature whatsoever like partnership or commission etc. in running the Retail Outlet as the same shall be operated and run exclusive by the corporation. The Corporation however reserves its right to change the operations of the Retail Outlet from COCO to dealership basis at its own discretion.
- 2. The Plot should be free from Overhead HIGH TENSION Power Line, Product / Water Pipelines/ Canals/ Drainage/ Nullahs / Public Road/ Railway lines etc.
- 3. The Plot should be free of all encumbrances/encroachments/religious structure etc Necessary documents to this effect duly notarized shall be furnish along with the offer.

- 4. Frontage of the plot of land should be abutting the main road, with proper approach road to the plot of land.
- 5. The land offered on a National Highway should meet MORTH / NHAI / HW norms.
- 6. Within City / Town limits, plots of smaller dimensions can also be considered, provided they are suitable for setting up a Retail Outlet.
- 7. For all locations, IOCL reserves the right to consider and procure more than one site subject to techno-commercial viability of sites and each site meeting sales potential norms / found feasible.
- 8. The bidder shall arrange for all statutory clearances such as Urban Land Ceiling, Non-Agricultural conversion, Income Tax clearance, Non-Encumbrance certificate etc.
