## **Important Instructions:-**

- The prescribed qualification from Govt. recognized University /Institute as a regular student
- The requirement of percentage marks in qualification is relaxed to minimum 55% for SC/ST candidates, if sufficient nos. of SC candidates with 1st Division is not available
