- iii. Semester-wise / year-wise mark sheets and Certificate of full-time Diploma in Engineering in respective Discipline.
- iv. Valid Discharge Certificate for Ex-servicemen candidates.
- v. No Objection Certificate in case of candidates employed in the Govt./Semi-Govt./PSU.
- vi. 01 passport size colour photograph.
- vii. Any other certificate, if applicable.
