#### **Brief about E-fueling:**

- A project where the vendor shall develop an application for generating the delivery ticket for a refuelling operation to aircraft by integrating with the airline hub / system in real time.
- The system should have provision to receive communication of fuel requirement from airline hub / system. The fuel order will be directly communicated from the device inside cockpit of the aircraft to the receiver device fitted in the refuelling equipment. After receipt of the confirmed fuel figure, refuelling will be carried out.
- Upon completion of refuelling, the actual volume of fuel delivered to the aircraft is electronically communicated to the cockpit device. The Pilot/Engineer acknowledges the quantity of fuel received in the aircraft by digital mode. The acknowledged fuel data will be transmitted to the airline hub and IOCL back end server.
