INSTRUCTIONS FOR CANDIDATES

- 1. Candidates are advised to appear for the Written Examination on the date, time and venue mentioned above. Please reach at the Test Center one hour prior to the scheduled time. Candidates coming late for the Written Examination shall not be allowed to sit in the Written Examination after the commencement of the exam.
- 2. Further, Candidates need to come for Written Examination and subsequent selection process only in case Candidates meet the eligibility criteria for the post. In any stage of selection process if it is found that Candidates are not meeting the eligibility criteria for the post, Candidates candidature shall be liable for disqualification.
- 3. Candidature for this test is provisional and is subject to Candidates fulfilling the educational and other eligibility criteria prescribed for the post. Non-fulfillment of the prescribed requirements, if found later on, at any stage of selection or after that, will render candidature liable for disqualification unilaterally without any notice.
- 4. Selection process shall consist of Written Examination, Computer Proficiency Test (in written format) and Personal Interview. Candidates have to qualify each stage of selection process to be eligible for short-listing to next stage of selection process. The Selection Criteria is attached.
- 5. The Written Examination shall be of Objective Type Multiple Choice Questions (MCQ) consisting of 4 options with one correct option. Candidate has to choose the correct option. There shall be total 120 objective type questions on General Aptitude and Reasoning, General English / Hindi, Numerical Aptitude and General Knowledge.
- 6. Candidates who are short-listed from Written Examination for Computer Proficiency Test, they have to appear in the Computer Proficiency Test on the next day of Written Examination; i.e. on 27.03.2017.
- 7. The Computer Proficiency Test (CPT) shall be for 60 minutes and consist of the following three components namely MS Word (10 marks), MS Excel Test (10 marks) and MS PowerPoint Test (5 marks). The CPT will be conducted in Microsoft Office in computer. The total marks of the CPT shall be 25 with duration of 60 minutes for completing all the three parts. The candidate shall be given the matter in the Question Paper which they have to type/ reproduce in the Computer including formatting of text and use of formulae etc. as per instructions given in the Question Papers.
- 8. Only those candidates, who are short-listed from Computer Proficiency Test, shall be eligible to appear in Personal Interview.
- 9. The minimum qualifying marks in Written Examination, Computer Proficiency Test and Personal Interview and other selection process is already detailed in the notification of vacancies in IOCL's website www.iocl.com.
- 10. This Admit Card should be mandatorily brought to the examination center and handed over to the Room Invigilator failing which entry in the examination hall will not be permitted.

- 11. If the name of the candidate is appearing in the list of eligible candidates for Written Examination in the IOCL Website, but he has not received the Admit Card, or the admit card has got misplaced, the candidate should reach at the Examination Center on the due date, before the reporting time along with a proof of ID for issuance of duplicate admit card to him.
- 12. Candidate should carry one passport size colour photograph, Pencil, Ball Pen (blue or black), Eraser, Sharpener and Scale at the Examination Center. Carrying of notes or books, calculators, correction fluid, mobile phones, any other communication devices, scanning devices, laptops etc. in the examination hall are not allowed. Any candidate found in possession of such unauthorized material or indulging in copying or adopting unfair means is liable to be summarily disqualified.
- 13. Candidates are required to carry a Photo ID Proof for the Written Examination / Computer Proficiency Test as well as in Personal Interview. The original Photo ID shall be checked and verified during the Tests. A self-attested photocopy of the same shall also be collected along with the admit card after the Written Test and Interview. Valid Photo ID proof like Aadhar Card, PAN Card, Driving license, Voter ID card, Passport etc. shall be accepted.
- 14. Candidates employed in Government/Semi government/Public Sector Organization must send their application through proper channel or produce "No Objection Certificate" at the time of appearing in the Interview. In case the candidate fails to do so, his/her candidature will not be considered.
- 15. The list of shortlisted candidates in the Written Examination and Computer Proficiency Test shall also be displayed in the IOCL website along with Time and Venue of the Computer Proficiency Test, either on the same day or the next working day. No other separate communication shall be sent to the candidates for informing the results of the Written Examination.
- 16. List of finally selected candidates to whom offer of appointment to be issued shall be displayed in the IOCL website either on the same day of the issuance of the Offer of appointment or the next working day.
- 17. Time of declaration of result of Written Examination and Computer Proficiency Test shall be announced in the Examination Hall immediately after the test is over. Candidates are advised to be present/available in the office gate after the test for their results. No separate communication shall be sent to the candidates in this regard.
- 18. Candidates appearing for Personal Interview shall be required to produce original documents of all relevant mark sheets of educational certificates, Date of Birth Proof, Caste/Disability Certificate/discharge certificate (wherever applicable) along with one set of photocopy of these documents duly attested along with them.
- 19. Candidates will have the option to take the test and interview either in Hindi or in English.
- 20. Candidates have to make their own arrangement for lodging and boarding for appearing in Test and Interview.
- 21. Outstation SC /ST candidates, who appear for Written Examination, shall be reimbursed to and fro fare limited to Second Class Rail/ Bus fare from their mailing address mentioned above OR from the place of actual journey, whichever is nearer to the place of Test, by the shortest route, on submission of proof of tickets as proof of journey.
- 22. Candidates possessing higher qualification than the prescribed as mentioned in the notification of vacancies published in IOCL's website www.iocl.com shall not be considered for the respective post.

- 23. Offer of Appointment shall be issued to the selected candidates and the list of selected candidates shall also be displayed in IOCL website. The selection of the candidate would be provisional and subject to verification of certificates / testimonials etc.
- 24. Finally selected candidates need to fulfill the medical fitness criteria and submit Pre-Employment Medical Fitness Certificate at the time of joining which is pre-requisite condition for employment.
- 25. In case it is found/ known at any stage of recruitment or thereafter that a candidate does not fulfill the eligibility norms and / or that he has furnished any incorrect / false information / certificate / documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of the information or material particulars as furnished by the candidate to the Corporation are found to be untrue or incorrect at any stage before or after his/her selection, then the same shall amount to misrepresentation/ fraud and his/her services shall be liable to be terminated unilaterally by the Corporation.
- 26. Please keep a copy of the Admit Card for future reference, as this original Admit Card shall be collected from Candidates at the Test center.
- 27. Canvassing in any form shall disqualify the candidature.
- 28. The decision of the Management in all matters relating to eligibility, acceptance or rejection of the application, mode of selection etc. will be final and no enquiry will be entertained in this regard.
- 29. Visually Handicapped candidates / those candidates whose writing speed is affected by Cerebral Palsy who wish to avail the assistance of scribe for writing answer on their behalf may please fill the attached declaration form for scribe and carry the same to the examination centre. The scribe is to be identified by the candidate at own cost as per our choice
- 30. All disputes would be subject to jurisdiction of Courts/Tribunals in Cuttack.
- 31. The select6ion process and other terms and conditions pertaining to the recruitment process have been detailed in the Notification of vacancies in IOCL's website. Candidates are advised to go through the same.
- 32. Candidates are advised to visit www.iocl.com from time to time for results of Written Examination, Computer Proficiency Test, Personal Interview and any other information.
- 33.
