- Two nos. of latest passport size photograph.
- Matriculation/HSC or other relevant certificate in support of Proof of Age (PAN Card, Voter ID Card, Passport, Driving License in support of Date of Birth are not acceptable)
- Mark-sheets starting from Matric, Intermediate and Degree/Diploma all semesters/years mark sheets/certificates and Final Diploma/Degree Certificate.
- Documents pertaining to Experience (Offer of Appointment, Current Pay Slip, Experience Certificate etc.)
- Candidates employed, directly or by or through any agency (including a contractor) by any Industrial Establishment will be required to furnish copy of the work order issued to the agency/contractor.
- Candidates employed in Govt./Govt. Departments/PSUs/Autonomous Bodies will be required to submit 'No Objection Certificate'.
- SC/ST/EWS Certificate in the prescribed format.
- Latest OBC Caste Certificate (Non-Creamy Layer) should be in the prescribed format. The caste/community should be included in the Central/ Common list of OBCs.
- Candidates who do not meet the eligibility criteria as per Advt. No. JR/5/2019, are advised not to appear for SPPT.
- It is clarified to the candidates that their candidature is PROVISIONAL and is subject to their meeting the prescribed eligibility criteria (Refer advt. No. JR/5/2019) and subsequent verification of certificates/ testimonials. At any stage, if it is found that a candidate has furnished false or incorrect information then his candidature is liable to be cancelled.
