- 4. Safety certificates under rule 33 issued by recognized competent person(Origional + 2 copies).
- 5, 3 copies of certificate of periodic tests of vessel and safety valve under rules 18 & 19 (not required for new vessels).
- No Objection Certificate Original Under Rule 46-A of Static & Mobile pressure vessels (Unfierd) Rule 1981 from District Authority along with a site plan any endorsed by him ( not required for nontoxic/non-flammable gas).
- 7. Bank draft for requisite licence fee drawn on a Nationalised Bank in favour of Chief Controller of Explosives payable at Nagpur (Rs. 1000/- for first 5000 liter or part thereof, and Rs. 500 for every additional 1000 liter or part thereof, limited to maximum of Rs. 10,000/- per year - maximum 3 years licence fees is acceptable).

- 1. The clearance is without prejudice to the stipulations and conditions laid down by other statutory bodies like Pollution Control Board, Explosive Department, Town Planning Department, Fire Service Department, Factories and Boilers Department and Science Technology and Environment Department (STED).
- 2. The management should strictly follow the recommendations of the Environment Impact Assessment Report and Disaster Management Plan.
- 3. The management should prepare a "Contingency Plan" for meeting emergencies in the transportation of LPG through road and submit to the concerned authority (District, Collector, Ernakulam) and the same shall be extended to other Districts
- 4. A suitable multiple vehicle to carry Hazmat equipment should be provided and made available in the site.
- 5. A mobile Evacuation system for transfer of volatile and toxic gases should be provided and made available in the site. The two items No.(4 & 5) are highly essential for meeting the emergency purpose in case of accident occurring during the course of transportation of LPG through Public roads.
