However, only those candidates, who are found FIT by the Committee in SPPT, shall only be considered for inclusion in Final Merit list cum selection list based on their marks in the Written Test. The details of selection process for SPPT is already mentioned in our website notification dated 27.04.2017.

DOCUMENTS REQUIRED FOR VERIFICATION

- 1) The following original documents along with a self attested copies are required to be furnished at the time of SPPT:
 - 10th pass/Matriculation certificate issued by the concerned education board as proof of Date of Birth. No other document will be accepted for verification of Date of Birth
 - ii) SC/ST/OBC certificates of reserved category candidates in the prescribed format issued by the Competent Authority. Further, OBC Non-creamy layer status should be valid as on 26.4.2017 and date of issuance of OBC certificate should be on or after 27.04.2016. Formats of Certificate are available in the Detailed Notification as well as in https://plis.indianoilpipelines.in under Downloads section
 - iii) Semester-wise / year-wise mark sheets and Certificate of full-time ITI / Diploma in Engineering in respective Discipline

iv) Valid discharge Certificate for Ex-servicemen candidates

- v) No Objection Certificate, in case of candidates employed in Government / Semi Government / Public Sector Organization
- vi) One Passport size colour Photograph
- vii) Any other Certificate, if applicable

IMPORTANT

- 1. Without original documents, candidates shall not be allowed to appear in SPPT.
- After checking, original documents shall be returned to the candidates on the same day and only the self-attested copies shall be retained by IOCL. Candidate himself shall be responsible for safe custody of original documents.
- 3. During document verification before the SPPT or at any stage of selection process, in case it is detected that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s) or is unable to produce original documents or possesses higher qualification, his/her candidature will stand cancelled.
- The information furnished by the candidate in the online portal with regard to qualification, age, category etc. shall be cross-checked from the original documents of the candidates.
- 5. Please note that during subsequent verification of documents, in case the revelation is contrary to your claim, your candidature will be summarily rejected at any stage of the selection process without any further notice to you.
