2	Fire & Safety Candidates has to compulsorily appear for both SPPT on 16/04/2018 (as per Sl No. 1 above) and Physical Standard on 17/04/2018 at 09:00 AM, at Panipat Refinery Township Hospital. Candidates are advised to make their own arrangement for stay.

3	Candidates are advised to bring all Original documents alongwith self-authenticated copies of all testimonials as mentioned in Check List (Advertisement) at the time of SPPT for verification. Failing which their candidature shall be rejected.
4	Candidates are advised to carry copy of their Written Test Call Letter alongwith valid I.D. Proof.
5	Candidates are required to wear Industrial Safety Shoes at the time of SPPT on their own arrangement.
6	Candidates who are working in Govt./PSUs/Semi-Govt./Autonomous Bodies need to submit the No Objection Certificate (NOC) . Failing which they will not be allowed to appear for SPPT.
7	The candidature of all the shortlisted candidates is provisional and subject to their meeting the prescribed eligibility criteria as notified. In case any candidates do not meet the prescribed eligibility criteria, they are requested not to appear for the SPPT.
8	The candidature of any candidate is liable to be cancelled, if at any stage it is found that the candidate does not meet the prescribed eligibility criteria. Merely getting shortlisted for the SPPT does not confer any right for appointment.
9	SC/ST/PwBD candidates appearing for SPPT will be reimbursed single second class railway fare from the nearest railway station of the mailing address to the place of test and back by the shortest route on production of ticket, provided the distance is not less than 30 KMs.
